# LIBBY SARTAIN BIDS FAREWELL AS PRESIDENT OF BCHS



Bruce Lee, the Actor and Martial Arts Instructor, once famously said; "A goal is not always meant to be reached, it often serves simply as something to aim at."

At BCHS, we have not only aimed, we have reached many of the goals set by our Trustees in a Long-Range Plan 10 years ago.

Our new Museum and Visitor Center opened just two years ago with only one exhibit. In the last year, we have opened six exhibits, under the leadership of Trustee Robbie Sanders, to complete our front gallery. Construction has begun on the walls in the Maynard Gallery. We also presented several temporary exhibits including: "The Grey Ghost;" "Ascension Catholic Church 150 years;" "The Way Things Were: Texas Settlers and Their Buildings, 1860s–1930s;" "The Hispanic Heritage of Bastrop County;" and two quilt exhibits by the Bastrop Senior Center. Look for a new exhibit in honor of Black History Month in February.

This past spring our Visitor Center hosted the Texas Geocache Challenge including a Spit off the Bridge event, making it one of the top tourist attractions in Bastrop. We hosted 10 tour groups of all ages from 4th graders through Seniors; made presentations

to Rotary, DAR, Texas Downtown Association, and LCRA; sponsored the Texas Ranger Cross Ceremony at Fairview Cemetery; and hosted the Texas Historical Commission Oral History Program. Our location and advertising initiatives, including a new website, increased Museum visitors by 400 percent, and tourists by 15 to 20 percent. We have successfully held garage sales and Historic Homes Tours and Rendezvous to help fund our programming. Our financial health is strong with six months of operations expenses in reserves. And, Nancy Scott and her army of volunteers are planning for our next garage sale in March.

We cannot rest on these laurels, so in 2014 we refreshed our long-range plan to take us through the next five years. Our areas of focus are:

- Exhibits and Archives
- Programs
- Awareness and Promotion
- Resources
- Tourists and Patrons

For 2015 we have established some challenging goals:

- Raise \$150k to complete permanent exhibits
- Plan to hire Executive Director by April 1
- Plan and install at least two temporary Exhibits
- Develop and implement archive and artifact acquisition program focused on Bastrop history since 1950
- Develop marketing programs to raise awareness of our research and museum exhibits, and Visitor Center
- Offer historical/tourism programs to target students and families
- Add at least one more fundraising activity

It has been my great pleasure to serve as your President for the last two years. I will continue to serve as a Trustee with Sandra Chipley as our next President. If you have some time to volunteer in 2015, let us know. We will need leaders, volunteers and help to accomplish these goals, which are more than just something to aim at! %

## PAINTING FOR SETTLER'S EXHIBIT REVEALED AT 2014 RENDEZVOUS

The Society gave Rendezvous gala attendees a preview of part of a new exhibit under construction at the museum. The exhibit planned in the Maynard River Room will be "Settlement Life" in early Bastrop. The painting by artist Lee Jamison depicts the true story of a wedding in Bastrop, circa 1830.

During that time, those wishing to marry would have to wait for a Catholic priest to travel to Bastrop from the missions in San Antonio. It was sometimes two or three years between visits. Until then, the prospective bride and groom would sign a contract to formalize their union and allow for the eventual birth of their children. Then, when a priest arrived, all the couples would come together to be married at the same time. Jamison's painting is based on the story of the marriage of 25 couples. The painting was on display at the event, along with Josiah Wilbarger's desk and a dress worn by Wilbarger's daughter, Mary.%

## Bastrop County Historical Society Quarterly Meeting January 22, 2015, 6:45 pm An Overview of TxDOT's Agricultural Theme Study for Central Texas: A Guide for Identifying and Understanding Agricultural Properties

Join us at the next BCHS Quarterly Meeting, Thursday, January 22, 2015, at Calvary Episcopal Church's Heritage Hall Building on Main Street. Our speaker, the historian David W. Moore, Jr., is President and co-founder of Hardy-Heck-Moore, Inc. (HHM), an Austin-based historic preservation firm established in 1983. After graduating from the University of Texas with a degree in History in 1977, Moore accepted a position with the National Register Department at the Texas Historical Commission (THC). His primary responsibility included the preparation of National Register nominations and among the projects he worked on during his tenure at the THC was the Bastrop Multiple Resource nomination, the first such document in the nation. After leaving the THC, he co-founded HHM, a firm dedicated to the identification, documentation, and evaluation of historic resources. HHM since

has documented over 200,000 historic resources in all 50 states and Puerto Rico, while the firm's base of operations remains firmly tied to Texas and its rich history and architectural heritage.

Moore will discuss a recently completed study he prepared for the Texas Department of Transportation that describes how to document and assess agricultural properties in Central Texas. The project encompassed a 17-county region that included Bastrop County. The report identifies repositories that contain materials describing the history of agriculture in the region, historic maps that depict cultural landscape features associated with agricultural activities, and types of resources and patterns of development that provide a tangible link to the past. Although the study was prepared primarily for consultants who submit reports and studies for TxDOT-related projects, it contains a wealth of information, methods, and techniques that will allow members of the public to learn more about the history and culture of any rural setting in the region.
